Extended Care

FUMC Preschool charges extra for extended care as available outside the hours designated on the contract. **Contract pick-up times are firm** – additional fees could incur. **Extended care rates are as follows:** After 1:03 (half day) or 6:03 (full day), the charge will be a minimum of \$25 per event, unless waived by management.

I agree to pay _____ in monthly tuition to St Pete FUMC Preschool. Tuition is due the 1st of each month **regardless of attendance or calendar holidays**. I further understand that I will be charged a \$45.00 late fee if tuition is paid after the 15th of the month.

Holiday “camp” programs (Thanksgiving, Christmas, Spring Break, Summer) **are NOT included in the monthly rate and are paid separately.**

Summer is through special registration only – not guaranteed – on a first-come, first-serve basis (registration is available beginning in March).

We require a one-month notice if your child is leaving the school.
